In accordance with this policy, announced in October 2005 at http://www.soc.nii.ac.jp/msj6/shuppan/bull_crtr2005-en.pdf, the Society has been asking authors of articles published in the Journal to transfer their copyright.

However, as of October 2009, we have not received any response from the authors of the nine articles listed below. It is very much in the interests of the mathematical community that the electronic Journal contains all papers published. For this reason we have decided to place the following nine JMSJ articles on the web.
